 A 50% deposit of the total accommodation cost is required to confirm your reservations. The balance of each accommodation reservation is due 30 days prior to arrival. A 100% deposit is required for reservations booked within 30 days of the arrival date. Date change requests can be made within the current winter season, are subject to availability and will incur an amendment fee of \$60.00 per amendment, plus any difference in rate. We do not accept date changes within 30 days of arrival. A 2-night minimum stay is required and Friday & Saturday nights must be booked together. Priority advance member bookings will only be accepted by 2024 financial members. Members accommodation insurance is strongly recommended to be purchased at the time of booking.  
 Cancellation Policy: All deposits are non-refundable. Any request to cancel and receive a refund must be received in writing at least 30 days prior to arrival.
